  - c. Discussion (suggestions, updates, output, process and timeline):
    - i. We currently have library institutions, healthcare, higher ed, government and K12 are we missing anyone?
      - 1. Public service i.e. National Weather Service
        - a. Could we add another category for organizations that don't fall in one of those verticals? Yes.
        - b. We could us "cultural organizations" this could fit for museums and other non-profits.
      - 2. Does anyone else use different language or have any others to add?

- a. Public radio. These could fall under "public media" as a category.
- b. Nonprofit cultural institutions
- c. Would all of these fit under a "nonprofit" or is that too general?
  - i. When we talk about value, we'd want to be more specific
- d. Electric Co-Op, Ag Research and Co-Ops are a couple others
- 3. The intent of the folder is to provide a template that can be used to create documents for each of these verticals.
- ii. Could we add testimonials?
  - 1. Yes.
  - 2. In the high-level document? Or one to work in each of the verticals? Both. Would be good to have a testimonial in the main document and then a list of testimonials available a repository by vertical for regionals to pull into the main document as they align in a specific instance.
  - 3. It could be sliced by vertical market, use cases, benefits, etc. so it would be good to consider the architecture of the whole document.
- iii. Is there a reason the higher ed icon is larger than the others?
  - It was to highlight where the R&E roots are (in higher ed) also to demonstrate that it's a consistent common vertical across the regionals.
     All of them have this vertical compared to the other verticals.
  - 2. Does it make sense to keep it that way?
    - a. No. Keep everything equal. Agreed.
- iv. Is CEN going to be working on this again with The Quilt? I hope so.
- v. Cloud is more important now than when we did this before.
  - 1. Consider these three buckets
    - a. Advanced transport architecture
    - b. Network to cloud
    - c. Security
      - i. Does anyone have anything that has already been written and has been successful?
        - 1. Nimota to send Jennifer the language that OSHEAN uses for Security.
- vi. Are there any others that need to go on or come off determine which are the biggest values.
  - 1. Elicit from this high-level doc
    - a. Have them call on a subject that isn't something we used to be known for, i.e. we'd like them to call us when they're considering migrating to the cloud or security, for example.
  - 2. We need a call to action? Yes, we want this to elicit that response when they're reading this.
    - a. We could add language that says to call and where to find us.
  - 3. Update the statement to include all the services/offerings at the bottom
    - a. Content/purpose-routing vs traditional commodity routing
  - 4. Resource sharing cuts across all three of the main columns
  - 5. Add a space to plug in an individual RENs organizational information along the lines of that call to action

- vii. REN is not defined on the document.
  - 1. Use Research and Education Network (REN) in the document so it defines the REN
  - 2. Are there for-profit RENs? Yes.
- viii. Anything else to add?
  - 1. Does it work to have that the network is part of a national and international community? Yes.
    - a. Do we draw this out as a separate benefit?
    - b. Does redundant work in this section? Resilient is a better word.
  - 2. Do we highlight the communities of practice in the document? No.
    - a. Rework the "nationwide communities" to be "communities of practice".
- d. Jennifer to clean up the language of the main document and start work on the testimonial repository
- e. Committee members to send Jennifer language they've used with success to be added to the repository as well.
